

Shays Exotic Cats LLC: Deposit and Reserve Kitten/Cat Form and Receipt: Page 3:

The purchaser will pay a deposit to reserve a specific kitten/cat which shall be applied towards the purchase price of said kitten/cat. The balance will be due and paid upon the release of kitten/Cat to purchaser, **along with one deposit, one Purchase Agreement, one Health Guarantee, along with other contracts, documents, acknowledgement and understanding forms, to be agreed to and signed for each kitten/cat purchased.**

This deposit is NON-REFUNDABLE. Should the Purchaser for any reason change his/her mind and decide not to buy a kitten/cat, the entire deposit is forfeited.

If unforeseen circumstances prevent the Purchaser from receiving a reserved kitten/cat, Shays Exotic Cats LLC has the option of offering a replacement kitten/cat of similar quality which Purchaser may accept or decline. **The deposit may be applied towards a future kitten/cat.**

Seller reserves the right to refuse to sell a kitten/cat to the Purchaser at any time prior to the kitten/cat's pick up. In that instance, Shays Exotic Cats LLC shall notify the Purchaser in writing of its decision, the reason for the decision and Shays Exotic Cats LLC shall refund Purchaser's deposit, at which time all agreements are null and void.

Shays Exotic Cats LLC's decision to cancel the sale shall be motivated solely by the best interests of the kitten/cat and potential relationship with the Purchaser. In addition to ensuring the kitten/cat will be going to the home best suited for him/her. One of Shays Exotic Cats LLC priority is to have good relationships with our clients. It is very important to communicate with each other.

If you do not call and/ or do not show up for your pick-up appointment date and time below, your deposit will not be refunded, and we will not hold the kitten/cat for you. Shays Exotic Catts LLC will consider that as a walk out/cancelation and all agreements will be null and void. **If you reschedule Kitten/Cat pick-up date, a \$100.00 fee will be added to the total amount due EACH time you reschedule. If you cancel or need to reschedule for the 3rd time,** Shays Exotic Cats LLC has the right to cancel your purchase and the deposit will not be refunded, and all agreements will be null and void. Shays Exotic Cats LLC will decide if the deposit can be applied towards a different kitten/cat or not based on reasoning for no shows. ***MUST READ, ACKNOWLEDGE AND SIGN SHAYS EXOTIC CATS LLC: SHIPPING CONTRACT if you plan on having a shipping company or person pick up and transporting cat/kitten to you. Shays Exotic Cats LLC may delay/ reschedule pick up if any issues/or incidents arrive due to care or needs of the cat/kitten or Shays Exotic Cats LLC (you will not be charged for those incidences).**
