The purchaser of the Kitten(s)/Cat(s) will find, hire, pay for and facilitate the shipping/transport company and/or person.

Shays Exotic Cats LLC will work with a shipping/transport company and/or person of your choosing.

The purchaser is to give Shays Exotic Cats LLC authorization to communicate with shipping personnel or person.

The purchaser is to give Shays Exotic Cats LLC authorization to be able to check progress/ location during shipping/transport if possible.

before Shays Exotic Cats LLC will turn over/release the Kitten(s)/ Cat(s) to the shipping/transport company and/or person. You must have paid all charges and fees in full. You must sign all contracts, agreements, and acknowledgement forms. You must have a veterinarian exam visit set up with in 24 hours of receiving cat/kitten and give Shays Exotic Cats LLC the time and date of veterinarian visit.

The purchaser will be solely responsible of the purchased Kitten(s)/Cat(s) once the shipping/ transport company takes possession of the Kitten(s)/Cat(s). The purchaser releases Shays Exotic Cats LLC of all liability of all issues including illnesses, death, missing, lost, and injuries of any kind to Kitten(s)/Cat(s) or any personnel during the time of shipping/ transport.

All Kitten(s)/Cat(s) MUST LEAVE in a durable/safe Kitten/Cat carrier, Shays Exotic Cats LLC will provide Kitten(s)/Cat(s) carrier for additional fee if one is not supplied through your shipping/ transport company and/or person.

The purchaser must follow shipping/transport company and/or persons rules.

Shays Exotic Cats LLC will issue no refunds of any kind if something happens to Kitten(S)/Cat(s) while in shipping/transport company and/ or person(s) care! When the cat(s)/kitten(s) are transferred over to Shipping company or person Shays Exotic Cats LLC is no longer responsible for the cat(s)/kitten(s).

The purchaser must notify Shays Exotic Cats LLC with-in 4 hours of when the Kitten(s)/Cat(s) arrive/delivered to you by one of the following ways: email, text message, Facebook message, or message through website. If Shays Exotic Cats LLC is not notified with in 4 hours the Health Guarantee will be voided. You must send veterinarian visit exam to shaysexoticcatsllc@gmail.com with in 48 hours of visit. If not Shays Exotic Cats LLC: Health Guarantee: Pages 9 and 10 will be voided, and Shays Exotic Cats LLC: Purchase Agreement: Pages 7 and 8 will be also voided.
