

## Shays Exotic Cats LLC: Deposit and Reserve Kitten/Cat Form and Receipt: Page 3:

The purchaser will pay a deposit to reserve a specific kitten/cat which shall be applied towards the purchase price of said kitten/cat. The balance will be due and paid upon the release of kitten/cat to the purchaser, along with one deposit, one Purchase Agreement/ Health Guarantee, along with other documents, acknowledgement and understanding forms, to be agreed to and signed for each kitten/cat purchased. This deposit is NON-REFUNDABLE. Should the Purchaser for any reason change his/her mind and decide to back out and not to buy a kitten/cat, or to wait for the next litter AFTER You have PICKED OUT your kitten/cat the entire deposit will be forfeited. The purchaser will need to place another deposit if you need to wait due to your circumstances. We need to find the kitten a new home on short notices. Deposits are used to help care for all of the Bengals, for example vet exams, x-rays, food, cleaning supplies, and medications as needed.

If unforeseen circumstances prevent the Purchaser from receiving a reserved kitten/cat, Shays Exotic Cats LLC has the option of offering a replacement kitten/cat of similar quality which Purchaser may accept or decline. The deposit may be applied towards a future kitten/cat. We start with Client #1 and move down the client list on each litter. Each client has 12 hours to pick from available kittens, pass or take the last available kitten. If passed you will have to wait until the next litter. Clients have right to change mind for example originally wanted a snow now wants a brown you have the right to choose just may have to wait until next litter. All clients will be asked if they want whatever color or gender even if it is not your preference you can just pass (you have the right to change your mind) before we move to the next client in paid order until all kittens are taken.

Seller reserves the right to refuse to sell a kitten/cat to the Purchaser at any time prior to the kitten/cat's pick up. In that instance, Shays Exotic Cats LLC shall notify the Purchaser in writing of its decision, the reason for the decision and Shays Exotic Cats LLC shall refund Purchaser's deposit, at which time all agreements are null and void. Shays Exotic Cats LLC's decision to cancel the sale shall be motivated solely by the best interests of the kitten/cat and potential relationship with the Purchaser. In addition to ensuring the kitten/cat will be going to the home best suited for him/her. One of Shays Exotic Cats LLC priority is to have good relationships with our clients. It is very important to communicate with each other.

Immunizations are an additional \$150.00 and will have to keep the kitten until 12 plus weeks and available upon request. Gender confirmation will be at kittens pre home vet check-ups. We are 99% accurate however, male testicals sometimes don't drop until after 8 weeks which makes it slightly difficult at times. If they are the wrong gender, you may keep, or pass and wait for the next litter.

We prefer you come to the Cattery to put down a deposit. If there is no show or last minute cancellation, and you still want to be put on the reservation list, we will request for you to do a deposit through Venmo with a 3% fee. Our time is as valuable as your time. If you can't pick up your kitten on pick up day for example out of town for a trip, we will charge an additional fee (amount depends on length of stay fee is under Lodging stay below). Lodging fee will be filled out prior to pick up and paid in full at the time of set up via Venmo with a 3% fee or cash. . \*MUST READ, ACKNOWLEDGE AND SIGN SHAYS EXOTIC CATS LLC: SHIPPING CONTRACT if you plan on having a shipping company or person pick up and transporting cat/kitten to you. Shays Exotic Cats LLC may delay/ reschedule pick up if any issues/or incidents arrive due to care or needs of the cat/kitten or Shays Exotic Cats LLC (you will not be charged for those incidents).
